IX. Call to Public: 1.) Joan Raetzel - lives in Parks and read letters from the community supporting our Fire Chief Wayne Marx - copy attached and will place copy in Mr. Marx file 2.) Rodger Anderson - The Woods consolidation timeline, Debra Hamby said they are waiting on Budgets, then will be working on process, just confirming that is what was said <u>3.) Martha Simoneau</u> wanted to know the numbers we have 3 chiefs & 3 captains and how many coming back 4.) Doug McKay how are you going to take on more jobs with the current numbers of volunteer - Erin addressed that with connection that we have with Coconino EMT training 5.) Karen McKay as full-time resident how do we find out if there is something wrong at the fire department? Bruce S. stated that is one reason to have our department web site 6.) Bruce Speirs made a comment that he wants to make a strong EMT department 7.) Wayne Marx stated that as far as volunteer - our history has been always a up and down trend in volunteers with 3-24 volunteers at any time. 8.)Ally Mitkowski she is a volunteer FF, wanted to comment on the training how professional it always is wit Wayne & Deirdre, we are a community and we back each other. She is getting EMT training, Wildfire training and Structure training. 9.) Pam Shipman has 2 issues – first this is an aging community & second young adult that cannot buy into the community, are only up here and they do not want to be part of the FD. Bruce commented that it is hard to find volunteers, young FF they want to come to a real department. It is good that we are looking at colleges to recruit. 10.) Bob Simoneau we have done a lot with a little, have been on fire calls for 5 years. The people that made comments have not been to calls. The calls I have been on, Chief counts on luck, not happening properly here. He worked at the Wildland Fire / Forest/ Police Officer and staffed 2-207 people. I am trained, many in big cities. Sent on fires. Here experience, we rely on luck. If you check the files you will only fine 2 complete files, mine and Martha's. I have gone to the Chief & Asst. Chief. I am filing a complaint with the Chief & Asst. Chief to the Board. 11.) Doug McKay, I have been here 14 yrs and 7 years on the department and quit the department because he felt that for the safety of the department, FF and community he could not continue with the environment, lack of oversight by the Board to investigate these complaints. 12.) Martha Simoneau followed with her complaint of the Chief and Asst. Chief to the Board 13. Millie I have been here along time, my husband was a instrument in this FD. What you all need to do now is communicate with the Board. 14.) Jack Hadley because we are a volunteer department, when I go out to recruit and there is a rift, I will wait til the department has worked this all out before recruiting. 14.) Sue Hamilton We will work with the AFDA rep to help us come back together 15.) Bruce Speirs stated he has been on the Board a short time, a resident for 6 yrs and came to Board meetings. Just Rodger and I showed. The rift did not start with me. I want to fix them and progress. My need to be flexible and work together. We need to increase our capabilities. Would need housing to help increase. We had an offer 2 yrs ago that did not happen with a grant. We need to work together to get this back. 15.) Mary Anderson we need a vison statement
