To the people of the Sherwood Forest Fire District who voted to recall Board Chairman Bruce Speirs: Shame on You!

In 2018, Mr. Speirs reluctantly agreed – his words -- to run for the board of the fire district because the then chairman, Rick Switzer, had announced that he would not seek reelection to the board and there was not anyone else who seemed interested in running, although the former fire chief eventually found another person to run against Mr. Speirs. When I informed the former fire chief that Mr. Speirs was interested in running for the board, his reaction was extremely negative toward the information for various reasons. I was surprised at his reaction since no one else had expressed any interest at all in the position, and I contacted Mr. Speirs to clarify with him his reasons for running because I didn't know Mr. Speirs. Even though his reason for running was none of my business, I was trying to understand the former fire chief's surprisingly negative reaction since he also told me that he didn't know Mr. Speirs. Mr. Speirs was friendly and gracious at my question and told me that the only reason he was running was because there was no one else who wanted to do it and that his intention was to continue with the work of the then-sitting board chairman in attempting to persuade the former fire chief to, among other things, comply with existing state rules, regulations, and mores because he was informed that that was not being done, and since the fire district was growing quickly with new homes and more residents, the operation of the fire department needed to keep up with the responsibilities going along with that growth. Personally, I internally applauded his vision because after more than two years of working at the fire department, I had observed many of those same issues and even had first-hand knowledge of the former fire chief's reluctance to comply with the board chairman's requests of him for information and work product. It was also my observation that the two other board members sitting with Mr. Switzer at that time were not supportive of Mr. Switzer's requests to the former fire chief, and that behavior also became the norm for a period of time when Mr. Speirs was on the board. When Mr. Speirs won the election to the board, the former fire chief said to me, among other things, "If he gets in my way, he will be recalled." Those words have stayed with me since November of 2018 because they were so harsh and arrogant, but as we have seen, the former fire chief made good on his threat. The charges leveled against Mr. Speirs in the recall petition were false and appalling, but it is clear that the former fire chief and his group are still at work in the district with their hateful rhetoric.

From my observation and my experience in working in the office of the fire department, every request that Mr. Speirs made of the fire chief was made in an effort to bring the former fire chief's operation of the fire department into compliance with said rules and regulations and to clean up the fire department facilities, which had devolved into premises resembling a filthy dumpsite, and every request Mr. Speirs made was met with delay, argument, obstruction, outright refusal, and, at times, contempt from the former fire chief.

I want to thank Mr. Speirs for his service to the fire board and apologize to him for the way he has been treated with the false accusations made against him. As a member of this fire district, I am embarrassed and appalled by the way the majority of voters of this district have taken his attempt to right a very wrong and dangerous situation in the running of the fire department to an indictment and vendetta against him personally by the allegations in the recall petition.

Last, but certainly not least, the Sherwood Forest Fire District is so very fortunate now to have a new fire chief and assistant fire chief who are working very hard to undo the damage done in the past. One can only hope that the new fire board will recognize the service these two men have done and are continuing to do to make sure that our fire department is operating in a legal, safe, and efficient manner for the firefighters, residents, and the public.

Activity:

- Incidents since last Board Meeting:

- Region is reporting a spike of Covid cases (FD).
- SFEFD and HCFD began a CO study this month. Nov 14 HCFD dispatched to sick person. CO alarmed at 107 ppm.

 - Enigne 1 (In Service) scheduled to recieve area lighting replacement, antenna replacement and a automatic charge system instalation
 - Engine 2 (Out of Service) classified as Reserve.

Training:




District Notes:


- The District participated in funeral ceremony for Firefighter Robert Augenstein from WFD. He served 45 years with the WFD as a volunteer.

- Administration issues including voting canvesing process, new recruit process, outlining a driver trainer process, work comp program, and Kadampa pre-event planning continues.


