#### 9. Call to the Public

**Chief Moede** elaborated on the calls he received from HCFD for assistance with several incidents. He distributed copies of an award presented to him personally for his assistance. The Sherwood FD was not involved in these incidences.

**Judd S**. expressed his appreciation for the expedience that **Chief Moede** brought to the expansion of the radio system. He also stated that he is making <u>NO</u> profit from his efforts to bring better internet access to the community.

**Warren W**. expressed concern with the postings of board meetings not being convenient. Several improvements were discussed. **Chairman Krushinsky** stated that the web site operator assured him that the agenda and notice of meeting had been posted. **Mr. Weir** said it wasn't on the web page. The **Chairman** said he would check on that.

**Paul C.** read an email he sent to **Bob Simoneau** apologizing for an incident that took place between the two of them on March 2<sup>nd</sup>. In the letter **Paul C.** suggested that any and all that have felt tension from past frictions start anew and strive to bring a better sense of community back to the levels that made our community so great in the past. **Judd S.** agreed and also suggested ways to get that message out. **Cathy C.** brought up the point that, due to Covid-19 we haven't been able to have the social gatherings as in the past and that this too, was a factor. **Judd S.** then described what we all could do to make this happen and that all parties and individuals involved need to spread this word. **Asst. Chief McDowell** then expressed agreement and explained that he and **Chief Moede** have discussed this subject.

Brie M. and Kathie K. discussed ways to make new residents feel included and appreciated.

Kathie K. expressed ways that our residents could lessen the fire risk in our community.

**Chairman Krushinsky** explained that the board had adopted a policy that if a meeting is requested from an outside entity that at least two (2) board members would be present for the meeting.

Judd S. explained that the fiber optic project for internet is a go but needs more people to sign up for it.

The subject of rental people abusing the community with noise, fire, etc. was discussed by all present.

The need for residents to have a "Go Bag" ready for evacuations was discussed by all present.
