Minutes

March 2, 2021

The Fire Board of the Sherwood Forest Estates Fire District met in special session on March 2, 2021 at 1:00 PM. Meeting was held at the firehouse located at 450 Little John Road, Williams, Arizona. The board may vote to go into executive session on any agenda item, pursuant to A.R.S. 38-431.03(A) (3) for legal advice with the District's attorney on matters as set forth in the agenda item. The following topics and any variables thereto, will be subject to Board consideration, discussion, approval, or other action. Note - All items are set for possible action.

- 3 **Attendance**: All board members were present. Chief Moede and Asst Chief McDowell were also present.
- 4. **Discussion** and possible action on the Bradbarrie Company's "Agritourism Camp" project.
 - a. Discussion included board concerns about liabilities, water resources, condition of roads to the project from the firehouse, consequences of not responding due to lack of firefighters or road conditions (especially deep snow), why Ponderosa FD turned down the coverage (distance), annual contract amount, fire wise inspections, medical staff on site, and concerns about ramifications to our insurance policies.
 - b. Chief Moede had distributed a 4 page draft of the service agreement at a previous board meeting for the board to review. At today's meeting he replaced it with an 11 page service agreement drawn up by an attorney.
 - c. The board chose not to make any further commitments until they had a chance to review the new agreement draft. All concerned decided that time to review the new agreement would be prudent. Chief Moede is going to check with our insurance carrier about any ramifications for our policies and any other issues that may arise.
- 5. **Call to the Public** Kathy Krushinsky expressed concern over the trucks that respond to a call, for the wear and tear from some primitive roads on the way to the camp. Catherine Cook asked if the agreement goes through, which account the monies would go into. Sue Hamilton responded that they would go into the Capital Funds.

- a. Rodger Anderson made a motion to adjourn and Steve Diefendorfer seconded. All agreed and the meeting was adjourned.

The email will be received as "Correspondence" and then read (paraphrased as appropriate) into the official SFEFD Fire Board meeting minutes during the "Public Comments" session and will become part of the official SFEFD Fire Board meeting minutes available for public review via the SFEFD website. Covid-19 Pandemic Emergency Provisions – The Sherwood Forest Estates Fire Board, during this time of Nation Emergency due to the COVID-19 Pandemic and the Arizona Governor's Executive Orders 2020-12 & 2020-36 effective May 12, 2020, is under official mandate to enact social distancing. As a consequence public attendance at all meetings shall be restricted on a first come first serve at the door, no reservations with the number of public permitted attendance based on available empty seats separated 6 feet distant, side to side and front to back, until the building is filled to capacity.
