- 2. Pledge of Allegiance
- 3. **Roll Call** Walt Krushinsky, Paul Cook, Sue Hamilton, Rodger Anderson, Chief Moede and Asst. Chief McDowell were present. Board member Steve Diefenderfer was not present.
- 4. <u>Approval of Minutes</u> for August 17, 2021 Meeting: Motion to approve was made by Sue Hamilton and Rodger Anderson seconded the motion. The Board voted unanimously to approve.
- 5. <u>Treasurer's Report</u> Treasurer, Sue Hamilton, reported we are in good standing financially and that the county had mistakenly charged an item to our account. The county is correcting their mistake but the monthly report would be delayed. The Board will vote to accept/not accept the report when it becomes available.

7. Old Business

Final corrections to the <u>Board Policies</u>, <u>Procedures and By-Laws</u> were made and Rodger Anderson made a motion to accept the changes. Paul Cook seconded the motion and the Board voted unanimously to accept the revised manual.

The Board discussed a resolution to amending Sherwood Forest Estate's southern boundaries. Sue Hamilton made a motion to accept the new resolution. Walt Krushinsky seconded the motion and the Board voted unanimously to accept the resolution.

8. New Business

The Board reviewed a resolution to accept the Coconino County Attorney's Office to represent the Sherwood Forest Estates Fire Board. Rodger Anderson made a motion to accept the resolution. Sue Hamilton seconded and the Board voted unanimously to accept the resolution.

10. Call to the Public

Sue Hadley brought up the lack of notification concerning Firefighter Burdikoff's ceremony and that there was no comprehensive system in place to communicate the date and time of the ceremony. Asst. Chief McDowell pointed out that, "Phones work both ways." Chief Moede explained that he asked FF Burdikoff's wife (Annie) what her wishes were and was told she would like to have the ceremony before her family left (three days). The Chief stated that he had no time for better planning and that he, "Won't apologize for anything...it worked and it worked well!" He earlier stated that he would not try to set something like this up again in a three-day time frame. Sue Hamilton reminded the Chief that the auxiliary was there to help the fire department with people and resources at any time.

Cathy Cook asked about progress on estimates for the new truck bays. Chief Moede stated that he had been very busy and just hadn't had time to pursue those estimates and that it wasn't even, "on his radar right now." It was pointed out that plans and/or blueprints were needed before contractors would be willing to give accurate bids.
