This discussion will be continued at future meetings but for these two months, Paul C. made a motion to accept as presented and Deb H. seconded the motion. The board voted unanimously to do so.)

# 6. **Reports**

- a. **Correspondence** Federal Govt. Census of Financial Details was passed on to the Treasurer to be passed on to the district's accountant. The government was contacted about this status and was told to ignore any late notices and return the form when completed.

  - c. **Fire Chief** Five incidences were reported. All were medical and all were in district.

Eight vehicles are currently in service with Trailer #10 still in process. The new vehicle has arrived (a fast-attack vehicle) and is intended to replace aging Brush #3.

Still waiting for the emergency power generator.

Diesel fuel station continues to be examined.

Old and broken snow chains for vehicles are being replaced.

Emergency planning for property ingress is being discussed for winter drive-way markers.

Warren Weir asked if the trucks were actually driven or just idled for monthly running. Asst. Chief McDowell stated that the trucks are usually driven around the neighborhood to help keep the fittings, bearings and other parts lubricated.
