The Fire Board of the Sherwood Forest Estates Fire District met in Regular session on September 19, 2023 at 6:00 PM. Meeting was held at the fire house at 450 Little John Road, Williams, Arizona. The following topics and any variables thereto, were subject to Board consideration, discussion, approval, or other action.

- 1. **Call to order** Meeting was called to order at 6:00 PM
- 2. Pledge of Allegiance
- 3. **Roll Call** All board members were present along with Chief Moede and Asst. Chief McDowell
- 4. **Approval of Minutes** Acceptance of the 9/19/2023 board meeting minutes were unanimously approved. Rodger A. made the motion and Paul C. seconded it.
- 5. **Treasurer's Report** Review of September, 2023 check details were discussed. Property taxes of \$3,294 were added to our accounts. Department balance is \$341,616.

Acceptance of September, 2023 financial details were unanimously approved following a motion by Rodger A. and seconded by Deb H.

6. Reports

- a. **Correspondence** Paul C. reported that the district's obligations for the **Federal Financial Census Survey** and the county's **Notice of Election** form has been satisfactorily submitted to the various sources.
- b. **Auxiliary** The auxiliary reported the purchase of an extraction saw (\$1773) and hats for the firefighters (\$500).
 - c. **Fire Chief** –The Chief reported the dept. responded to three incidences. All three were outside of our fire district on a mutual aid agreement between several depts.

All nine dept. vehicles reported as "in service" while several have minor fixes underway.

Septic repair still awaiting parts.

Fire station security system quotes on-going.

Bi-monthly trainings continue.

Received contributions from HCFR, Junipine FD and Ponderosa FD for access to our radio repeater "Red Channel".

The dept. participated in the Williams Patriot Day Parade.

Jud Swearingen informed all that the Valle FD also used our "red channel" radio frequency.

Cathy also stated that the POA will have openings for both the President and Vice-President positions for next year.
